<p><b>@</b> Travellers from these countries/regions/places may opt out of dedicated SHN facilities and serve their 14-day SHN at their place of residence, if they fulfil the following criteria:</p> <ul style="list-style-type: none"> <li>• Travelled to no other country than these countries/regions/places, in the last consecutive 14 days prior to departure for Singapore;</li> <li>• Are occupying their place of residence (i.e. residential address) alone, or only with household members with the same travel history, who are also serving their SHN of the same duration and period; and</li> <li>• There is no one ordinarily residing at the place of residence (e.g. domestic helper) who does not share the same travel history, and the traveller has already made all necessary arrangements to ensure that any such person will not reside at the place of residence until the conclusion of the SHN period.</li> </ul> <p>Applications must be made at least three (3) days prior to arrival. To apply for opt out, Singapore citizens (SC) and permanent residents (PRs) should click on the link <a href="#">here</a>.</p> <p>For Non-SCs/PRs, the request to opt out should be indicated when seeking entry approval into Singapore.</p> <p>The list of countries/regions/places eligible for opt-out of dedicated SHN facilities will be updated from time to time depending on the public health risk assessment. <u>Travellers must be prepared that any prior approvals given for opt-out from dedicated SHN facilities may be revoked</u>, and the prevailing border measures upon entry will apply, including stay in SHN Dedicated Facility (SDF) and payment, where applicable.</p> <p><b>Note:</b> From 22 November 2020, 2359hrs, all travellers entering Singapore with travel history in the past 14 days to Japan will be required to serve a 14-day SHN at dedicated SHN facilities, even if they have obtained approval to opt out earlier.</p>

<p>@All travellers entering Singapore from 22 November 2020, 2359hrs who have a travel history in the past 14 days to Malaysia will be required to serve a 14-day SHN at SHN Dedicated Facilities (SDF). All travellers (except Singapore Citizens (SCs) and Permanent Residents (PRs)) entering Singapore from 27 November 2020, 2359 hours, who have a travel history in the past 14 days to Malaysia will be required to take a COVID-19 polymerase chain reaction (PCR) test within 72 hours before departure.</p> <p>^From 22 November 2020, 2359hrs, all travellers with travel history in the past 14 days to Japan will be required to serve a 14-day SHN at SDF. These travellers will no longer be able to opt out of SDF and serve their 14-day SHN at their place of residence, even if they have obtained earlier approval.</p>				

#### Negative COVID-19 swab test taken within 72 hours before departure from place of disembarkation

<sup>#</sup>The COVID-19 PCR test result certificate should be in English and state the following:

- Traveller's name , date of birth, and passport number (as indicated in his/her passport);
- A negative COVID-19 PCR test result;
- Date and time when the COVID-19 PCR test was taken; and
- Name of the testing institution where the test was taken.

#### Chargeable Cost

The cost incurred for the COVID-19 swab test is chargeable for all travellers.

The cost incurred for the SDF is chargeable for all travellers, except Singapore citizens or permanent residents who have left Singapore before 27 March 2020 and return to Singapore on/ before 31 December 2020.
